ARTICLES OF INCORPORATION

GAY AND LESBIAN ALLIANCE OF THE CENTRAL COAST

I

The name of this corporation is the Gay And Lesbian Alliance of the Central Coast.

II

- A. This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.
- B. The specific purposes for which this corporation is organized are to educate the general public regarding lesbian, gay, bisexual and transgender issues by providing a speakers bureau and publishing a newsletter, and to provide charitable peer counseling and referral services for gay men, lesbians, bisexuals and transgendered persons.

III

The name and address in the State of California of this corporation's initial agent for service of process is Dana Belmonte, 1247 Vista del Lago, San Luis Obispo, California 93405.

IV

- A. This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.




